

# Freedom of Information Request for Records Relating to the 2020 Amendment to the Cayman Islands Constitution

#### Summary

During its engagements with the public, the Cayman Islands Constitutional Commission ("the Commission") is frequently asked about how the Cayman Islands Constitution Order 2009 ("the Constitution") is amended. To better understand this process, the Commission has sought to obtain records relating to how the Constitution was last amended in 2020. Accordingly, a number of requests for records were submitted in March 2023 to various government entities in the Cayman Islands under the Freedom of Information Act, as well as to the Foreign, Commonwealth and Development Office ("FCDO") (previously the Foreign and Commonwealth Office or "FCO") under the equivalent legislation in the United Kingdom ("UK"). This document summarises the Commission's requests and provides details of the responses received.

## **Background**

In 2018, the Commission was invited by the then Premier, Sir Alden McLaughlin, and the then Leader of the Opposition, Mr. Ezzard Miller, to make suggestions for additional minor amendments to the Constitution, which could be considered alongside other potential amendments that were already under discussion. At the same time the Commission was also tasked by the then Governor, Mr. Anwar Choudhury, to undertake research into the potential amendments that were being considered and to report on whether such amendments had been encompassed in the constitutional arrangements of any other UK Overseas Territories.

The Commission was pleased to be engaged and duly respond to both enquiries in its paper dated 27 June 2018. In this paper, the Commission: (i) highlighted the six potential revisions to the Constitution that were already under consideration, and commented on the same, with reference to the experiences of other UK Overseas Territories; (ii) accepted the limitation that any additional proposals had to be restricted to relatively minor amendments at this time, and therefore focussed on those aspects of the new Constitution that had given rise to confusion and uncertainties and which, in the Commission's view, would therefore benefit from clarification and greater precision; and (iii) recommended consideration of six other matters for potential amendment, which notably included the process by which the Constitution may be altered in the future.

It is not clear to the Commission what, if anything, happened with its recommendations; whether they were considered at the ensuing constitutional talks with the FCDO; or indeed, whether they were even presented at this time. The Commission has followed up with all relevant parties since then, not just in order to ascertain the position with respect to its recommendations, but also in an effort to obtain all relevant records relating to the process that ultimately resulted in the Cayman Islands Constitution (Amendment) Order 2020 ("the 2020 Amendment"). On 1 November 2022, the Commission was advised by His Excellency, the Governor, Mr. Martyn Roper, that there was: "no

additional documentation about the 2019/20 Constitutional negotiations from the UK or Cayman Governments that can be shared other than that which is already in the public domain."

The Commission believes that it has a legitimate interest in the process that resulted in the 2020 Amendment, because: (i) the Commission was requested to provide input into the process; (ii) the Commission was also expressly engaged by the UK's representative in the Cayman Islands in matters that were subsequently the subject of constitutional amendment in the 2020 Amendment; and (iii) not least because of the Commission's constitutional mandate "to advise the Government on questions concerning constitutional status and development in the Cayman Islands". Moreover, and in light of the sentiments regularly expressed to the Commission from members of the general public, the Commission takes the view that the people of the Cayman Islands ought to have access to all relevant documentation relating to an amendment of their Constitution and the Commission therefore resolved to submit requests for information in an effort to finally gain access to the same.

### Requests

On 16 March 2023, requests for records relating to the above concerns were submitted to various entities. In the Cayman Islands, these entities were: (i) the Office of the Premier; (ii) the Cabinet Office; (iii) the Portfolio of Legal Affairs; and (iv) the Governor's Office. A request for records was also made to the FCDO in the UK.

The Commission requested:

"... all relevant documentation relating to the process by which the Cayman Islands
Constitution was amended with the enactment of The Cayman Islands Constitution
(Amendment) Order 2020, including the records of the constitutional talks that were held at
the United Kingdom Government's Foreign and Commonwealth Office in December 2018
and all related documents and correspondence produced both before and after this meeting
and dating back to the inception of the proposals to amend the Cayman Islands Constitution
following the passing of the Sanctions and Anti-Money Laundering Act 2018 by the United
Kingdom Parliament. For the avoidance of any doubt, the records requested include, but are
not necessarily limited to, correspondence (both internal to the UK and Cayman Islands
Governments, between the UK Government and the Cayman Islands Government, and
between the UK or Cayman Islands Government and any third parties); documentation
relating to any related meetings, including minutes, notes, transcripts and other such
records; and any notes, memoranda or other record produced in connection with this
process and the amendment of the Cayman Islands Constitution."

### Responses

Over the ensuing nine months, the various entities targeted provided their responses to the requests, with the last final response received from the FCDO in December 2023. These responses are all available in full on the Commission's website, but, for ease of reference, the responses have been catalogued and summarised in the following table:

Insofar as the local entities are concerned, the Commission's attempt to obtain additional documentation relating to the 2020 Amendment has proved unsuccessful. While the Portfolio of Legal Affairs advised that the records requested were not within its remit, both the Office of the Premier and the Cabinet Office reported that their Offices did not hold any records that were relevant to the requests. The net result therefore was that, notwithstanding that the Commission had been invited to propose potential amendments to the Constitution, none of these local entities possessed any relevant records.

The Governor's Office did indicate that it had some records that were responsive to the request, but despite the Commission having been tasked by the former Governor in connection with research on amendments that were already being considered, the Commission was notified that these records

could not be made available because they belonged to another jurisdiction (namely the UK) or were claimed to be exempt for another reason.

Any hope of obtaining additional information regarding the 2020 Amendment therefore rested on the final response from the FCDO, which arrived on 14 December 2023; and, although the FCDO did release some correspondence, this content of the documentation released was still disappointing. The correspondence provided was heavily redacted and none of the attachments referenced in the correspondence were released. Moreover, there were apparently no records of the constitutional talks at all, which took place between the Governments of the UK and the Cayman Islands, and which resulted in the 2020 Amendment, that could be released.

The only information of any note that was released by the FCDO was a draft Parliamentary Statement concerning the Overseas Territories, which reads:

"I wish to give the following assurance to the Governments of the British overseas territories. Before it is proposed to legislate for an overseas territory by Act of Parliament or Order in Council, or to impose an international obligation on an overseas territory, the United Kingdom Government will normally consult the Government of that territory unless circumstances make it impracticable to do so. The United Kingdom Government will take due account of any views expressed by the Government of the territory concerned."

The FCDO's explanation for the limited release of records was fourfold. Firstly, it was stated that some relevant information was already available on the Cayman Islands Government website. Secondly, the FCDO relied upon an international relations exemption, which recognises that the UK's effective conduct of international relations depends upon maintaining trust and confidence between governments; and so, while there may have been a public interest in releasing this information, the public interest in maintaining this exemption was found to outweigh the public interest in disclosing it. Thirdly, redactions were also made to protect personal information; and, lastly, information that was considered to be subject to legal professional privilege was also withheld. On this final point, the FCDO explained that:

"It is important that the government is able to seek legal advice so that it can make its decisions in the correct legal context. The legal adviser must be in possession of all material facts in order to provide sound advice. The government must therefore, feel confident that it can disclose all relevant facts to its legal adviser. It should be able to do so without fearing that this information will be disclosed to the public."

# Conclusion

Given the importance of the Constitution, the Commission believes that any amendments to this fundamental document should be undertaken in manner that is as open and transparent as possible. In line with this belief, the Commission submitted a series of requests for records relating to the process by which the 2020 Amendment came into effect. These submissions did not, however, result in the release of any significant additional documentation relating to the 2020 Amendment.

Unfortunately, the Commission was not able to consider pursuing appeals of the final decisions of any of the entities targeted in these requests for records because the Commission has not been properly constituted since January 2023. It may be that in due course, once the Commission is reconstituted, this is a matter that could be revisited in fulfilment of the Commission's remit to promote understanding and awareness of the Constitution and its values. In any event, what the limited responses to the Commission's request do nevertheless indicate is that there is clearly a need for greater transparency in the process by which the Constitution is amended.

Good afternoon – I write with regard to your application under the FOI Act for records relating to the 2020 Cayman Islands constitutional amendment – FOI Request 102117.

The Governor's Office does hold some records which are responsive to your request.

However, the Freedom of Information Act (2021 Revision) ("the FOI Act") does not apply to records that belong to the Government of the United Kingdom and Northern Ireland whether they are created or held in the Cayman Islands or elsewhere (see section 3(5)(d) of the FOI Act).

I understand a similar request has also been made to the UK Government which will be dealt with by the UK authorities pursuant to the UK Freedom of Information Act 2000. It may follow that the records will be released by them.

There are three further documents which have been identified as responsive to your request. Following an internal review carried out by the Head of the Governor's Office these letters are exempt under section 15 (b) of the Act: "records contain information communicated in confidence to the Government by or on behalf of a foreign government or by an international Organisation".

In 2018, the Cayman Islands Constitutional Commission ("the Commission") was invited by the then Premier and then Leader of the Opposition to make additional suggestions for amendments to the 2009 Cayman Islands Constitution ("the Constitution") to supplement certain potential amendments that were already under discussion. At approximately the same time, the Commission was also tasked by the then Governor to provide research and context into those potential amendments being considered.

The Commission was pleased to provide this input and did so in its Paper dated 27 June 2018. It is not clear to the Commission what, if anything, happened with its recommendations therein. The Commission has consequently followed up repeatedly with all relevant parties in the interim period, in order to ascertain not just what happened with its recommendations, but also in an effort to obtain all relevant records relating to the ensuing process that ultimately resulted in the amendment of the Cayman Islands Constitution (The Cayman Islands Constitution (Amendment) Order 2020).

Most recently, these requests were encompassed within the Commission's correspondence of 15 October 2021, which dealt with a range of important constitutional matters, and which was, by convention, addressed to His Excellency, the Governor, the Hon. Premier and the Hon. Leader of the Opposition. On 1 November 2022, the Commission received a reply from His Excellency, the Governor, which in this regard advised that; "there is no additional documentation about the 2019/20 Constitutional negotiations from the UK or Cayman Governments that can be shared other than that which is already in the public domain."

I am writing to confirm that we have now completed the search for the information which you requested.

I can confirm that the Foreign, Commonwealth & Development Office (FCDO) does hold information relevant to your request. The information to which you are entitled is contained in the attached digest. Some information is being withheld under Section 21 (Information accessible to the applicant by other means).

We have made some redactions to the digest and withheld further information under Section 27 (International relations), Section 40 (Personal information) and S42 (Legal professional privilege) of the Freedom of Information Act 200 and I have explained the reasons for this below.

# Section 21 (Information accessible to the applicant by other means)

Some of the information is exempt from disclosure under section 21 (1) (Information accessible to the applicant by other means) of the Freedom of Information Act 2000. Some of the information you have requested is published on the Caymen Islands Government website and can be found <a href="https://example.com/here.">here.</a>

# **Section 27 (International Relations)**

Some of the information is exempt under Section 27(1)(a) of the Act. Section 27(1) (a) recognises the need to protect information that would be likely to prejudice relations between the United Kingdom and other states if it was disclosed. The application of s27 (1) (a) requires us to consider the public interest test arguments in favour of releasing and withholding the information. We acknowledge that releasing information on this issue would increase public knowledge about our relations with these states. However, s.27(1) (a) recognises that the effective conduct of international relations depends upon maintaining trust and confidence between governments. If the United Kingdom does not maintain this trust and confidence, its ability to protect and promote UK interests through international relations will be hampered, which will not be in the public interest. For these reasons we consider that, the public interest in maintaining this exemption outweighs the public interest in disclosing it.

# **Section 40 (Personal Information)**

Some of the information you have requested is personal data relating to third parties, the disclosure of which would contravene one of the data protection principles. In such circumstances sections 40(2) and 40 (3A) (a) of the FOIA apply. In this case, our view is that disclosure would breach the data protection principle that personal data should be processed lawfully, fairly and transparently. It is the fairness aspect of this principle, which, in our view, would be breached by disclosure. The personal information provided by the sending State to the FCDO (receiving State) is in confidence. In such circumstances, section 40 confers an absolute exemption on disclosure.

# Section 42 (Legal Professional Privilege)

Some of the information you have requested is exempt under section 42(1). Section 42(1) of the Act recognises the validity of withholding information that is subject to Legal Professional Privilege (LPP), which exists in order to encourage clients to be frank and open with their legal adviser. It is important that the government is able to seek legal advice so that it can make its decisions in the correct legal context. The legal adviser must be in possession of all material facts in order to provide sound advice. The government must therefore, feel confident that it can disclose all relevant facts to its legal adviser. It should be able to do so without fearing that this information will be disclosed to the public. In turn the legal adviser will consider the issues and the arguments and weigh up their relative merit. However, in the circumstances of this case, this public interest does not outweigh the opposing public interest in maintaining the current convention.
